### **LOGO USE REGULATION**

#### **Definition**

The Logo is the graphic symbol identifying CHARIS International. The Logo was registered on 03.11.2022 at the Ministry of Economic Development in Italy, with a regular certificate which I enclose.

#### **Graphical requirements**

The Logo may be reproduced in black and white - only for printing - or in colour, using only the same shades as the images shown above. The Logo may be reproduced in full size or larger or smaller than it, as long as its proportions are respected and its legibility is ensured. Partial reproduction of the Logo is not permitted. The Logo may be reproduced leaving the proportions of the images unaltered. It is not permitted to modify, alter, add, move, delete even part of the symbols, images, colours, proportions or text contained in the logo.

#### **Modalities of use**

The Logo is reserved exclusively for the statutory bodies. The International Service of Communion, the Continental Services of Communion and the National Services of Communion are granted the faculty to use the Logo exclusively within the scope of their institutional activities. The use of the Logo, on invitations, posters, brochures, press releases and similar documentation, as well as on websites, referring to events promoted by the statutory bodies, is authorised. The Logo may not be used on invitations, posters, brochures, press releases and similar documentation, as well as on websites, referring to events organised by entities registered with CHARIS.
